



TERMS AND CONDITIONS:

BRUSH & BUBBLES ART STUDIO

1.1 Confirmation of a Private Booking

- The booking is confirmed upon receipt of the hire deposit (\$250). By paying a deposit you are agreeing to Brush & Bubbles Terms and Conditions.
- Remaining balance and confirmation on numbers are due 7 days out from the event date.
- An additional Security bond may be required on top of deposit. Security bond will be refunded after the hire, less any incidentals or damage. Subject to event.
- Brush & Bubbles will be under no obligation to proceed with the booking if the deposit or full payment has not received within designated times.

1.2 Cancellation of a Confirmed Booking

- Should you wish to cancel a private event we require 5 week's notice from the events date to receive the deposit back in full.
- After the deposit has been paid cancellation will result in forfeiture of the deposit under 5 week's notice.
- The deposit is non-refundable • All amounts paid towards the hire are non-refundable.
- Booking is not transferable.
- Brush & Bubbles reserves the right to make alterations to our event programs, venues and timings.

1.3 Cancellation or Postponing due to COVID-19

- In the scenario that your session is cancelled due to a government mandated closure of our studio you will be able to receive a refund on the deposit or ability to postpone to a later date (subject to availability)
- Refunds or postponing of date will not be honoured if our studio is able to operate amongst other state lockdowns or restrictions.

1.4 CONDITIONS OF ENTRY TO STUDIO / COVID-19

During the COVID-19 pandemic, Brush & Bubbles will be taking all necessary precautions outlined by the state government. Brush & Bubbles reserve the right

to refuse entry or ask guests to leave the premises if they do not reasonably follow the below. We ask that guests assist in this by:

- Practice social distancing of 1.5m between others
 - Washing and sanitising hands
- Staying home if unwell or showing signs of the virus
- Staying home if tested positive or are awaiting test results

1.5 Attendance Numbers

- Client must meet the minimum number of attendees required for the class or equivalent in payment.
- Full payment is required at least 7 days out from our event date
- Once numbers are confirmed we are unable to provide a refund or credit should numbers alter in any way.

1.6 Event Time

- Events run for a 3-hour period as agreed when booking. Event must end at the end of the agreed time.
- If you would like to arrive earlier than your Arrival Time or leave later than your Departure Time, a charge of \$100 per 30 minutes applies.

1.7 Maximum Numbers

- Subject to restrictions imposed by the relevant government, we can accommodate up to 37 people however, during COVID, the attendee maximum number varies depending on the Government's restriction at the relevant time.

1.8. Off Site Events

- Is it the responsibility of the hirer to organise off site venue.
 - Tables and chairs must be required for all off site events
 - Bush & Bubbles will need to arrive at least 45 min before the event begins to set up.
- ### **1.9 Consumption Of Alcohol**
- You agree that you shall only consume alcohol at our studio if you are over the age of 18 years.
 - You may require suitable identification to prove your age.
 - If we believe that you are under the age of 18 years and you intend to consume or have consumed alcohol during OUR public sessions or private events, we have the right to ask to leave without compensation.
 - Guests will not be permitted into any of OUR studios or participate in any off-site public session or private event if you are intoxicated or WE believe you are intoxicated.
